

## **PCIT Therapist Online Training Activities**

Below please find (1) PCIT training activities that can be implemented online to build therapists' knowledge and skills; and (2) a numbered list of the PCIT competencies based on the current PCIT International Therapist Training Requirements (www.PCIT.org). Please note:

- 1. The suggestions in the asynchronous column are included because they *can* be done in a format that is not live. This does not mean they must be done that way. Many of these topics should also be discussed during live training sessions.
- 2. The amount of time associated with each activity is an estimate that will vary based on the number of trainees and trainee needs. Different trainers will allot different amounts of time to different activities. If unsure what is appropriate in your circumstances, please discuss with a Global Trainer.
- 3. The numbers listed under "Competencies" correspond to the competency guidelines (listed at the end). This <u>does not imply that the activity is</u> <u>sufficient</u> to help a therapist meet that competency or to count the competency as "checked off." It means only that the activity will help to build that particular skill.
- 4. This list is meant to help trainers develop their online training workshops. Please feel free to create your own activities and let us know what works!
- 5. These activities are not a replacement for therapy session review. As specified by the PCIT International Therapist Training Requirements, trainers must still check off all trainees on the CDI Teach, CDI Coach, PDI Teach, PDI Coach sessions. Review of the sessions can be done synchronously (live) via remote live consultation or asynchronously (non-live) via review of session recordings.

1	Administer, score, and interpret ECBI		
2	Administer, score, and interpret pre-treatment DPICS		
3	Achieve 80% coding reliability with trainer in 5-minutes of live coding or with a criteria tape using DPICS-IV		
4	Achieve 80% on all DPICS-IV Clinical Workbook quizzes		
5	Use DPICS to determine in-session coaching goals		
	Child Directed Interaction (CDI)		
6	Meet parent criteria for CDI skills (10 labeled praise, 10 behavioral descriptions;10 reflections; 3 or fewer criticism, questions, plus commands) in 5-minute interaction with child or 5-minute role play		
7	Present CDI-Teach adequately covering all non-optional items on the most recent (i.e., 2011 protocol) treatment integrity checklist.		
8	Model CDI skills in all interactions with families		
9	Demonstrate CDI Coaching ("adequate and sensitive coaching") per trainer's rating		
	Parent Directed Interaction (PDI)		
10	Present PDI-Teach adequately covering all non-optional items on the most recent (i.e., 2011 protocol) treatment integrity checklist.		
11	Effectively manage a PDI Coach session and accurately demonstrate the discipline sequence with a child during treatment or during role play.		
12	Demonstrate adequate and sensitive PDI coaching with actual client via video or live supervision.		
13	Explain PDI to child (during training week role-play or in session).		
14	Explain House Rules procedure covering all non-optional items (during training role-play or in session)		
15	Explain Public Behavior procedure covering all non-optional items (during training role-play or in session)
